Now on to future events. It is that time of the year when packages drop into your Club Secretary's in-box, one from the EAF Championship Secretary, another from the EAF Exhibition Secretary and finally one from the Treasurer with a request for Membership fees, all important.

You will see from the Championship and Exhibition Secretaries' information that there have been some changes to methods of entry, which will hopefully make entering easier for clubs. This is also a plea to more clubs to try to get together an entry in both the Championships or at least one of them – Prints or PDIs. Since Covid the entries have not recovered to pre-Pandemic numbers. I appreciate that we have fewer clubs in the Federation, which also means fewer members. However, on my travels around the clubs when I'm judging, I witness many images both in Prints and PDIs which would stand up well in these events. The bottom line is

that your club committee or, at least the club selection committee, have to be organised and hold a selection meeting. These two events are representing their club in the EAF. It is the old adage – "Use it or lose it". We don't want that to happen as both of these are qualifying events for the PAGB PDI and Print Championships held at Warwick and Blackburn respectively.

The Exhibition is different as it's not club entry, it's for individual members. It has to be entered via your club, but it is the individual member who chooses what they wish to enter. Again, I have seen many images which would grace the walls of the Wingfield Barns venue. The last two years the entry has been down, meaning that we had finished selection by early afternoon. Pre-Covid the colour prints would be assessed before lunch and the mono after lunch. How nice it would be to get back to that situation. It is, however, down to you, our members. Please try to support these events as they are so important to the success of our Federation.

And finally, as this is my last President's Piece, (where have the last 21 months gone?), I would like to thank most sincerely all the Executive Committee for their support over the last two years - it is a dedicated team effort. As a new President, one gets a two-year period in office but needs to rely on the long experience of some other members so I would

particularly like to thank Sue Dobson and Daphne Hanson for their guidance and advice. I also want to pass on to my successor, Nick Akers, my best wishes for a successful stint in office and hope he enjoys it as much as I have.

At the last PAGB Executive meeting the Standards and Guidance Sub Committee presented a previously circulated report on the use of AI in photographs. The report concluded that the existing wording in PAGB rules for competitions, shown below covers the use of AI.

**Images must be entirely the work of the Photographer. In composite images, all component images must meet this requirement. For the**

**avoidance of doubt, use of images from any other source including, but not limited to, royalty free image banks and clipart are not permitted.**

I understand that this edition will have a copy of the article published in e-news that further explains this rule.

FIAP have also issued the following document 260/2023:

*Pictures created by artificial intelligence are not allowed in salons run under FIAP patronage. Therefore salon organisers are asked to include the following text into the regulations of their events : PICTURES CREATED BY ARTIFICIAL INTELLIGENCE ARE NOT ALLOWED IN THIS SALON! It is reminded that all parts of the image have to be photographed by the author who is holding the copyright of all works submitted. Offenders will be sanctioned for life!*

## **CHAMPIONSHIP SECRETARY**

At the PAGB InterClub Print Championship in Blackburn we had four clubs from our area taking part :- Beyond Group, PICO, Colchester PS and Melbourn & DPC. Both of the latter were 'Rookie' clubs to this event, never having represented our region before.

In the preliminary round Beyond Group topped the table with Colchester and PICO also qualifying for the final of the Cup and Melbourn in joint lead of the chasing group in the Plate competition along with Smethwick and Poulton-le-Fylde PS. The final results of the Cup saw Colchester and Beyond Group tied in 4th place with 184 points and PICO in 8th Place on 180 points. Colchester, being the only 'Rookie' club to reach the Cup competition had already won the prize for best 'Rookie' club. In addition, Chrissie Westgate of Beyond Group was awarded the PAGB gold medal for best mono print for 'Muslim Girls' and Colin Westgate was awarded a PAGB silver medal and judge's choice for best Monochrome by Erica Oram for 'Village Girl'. When the Plate competition result was announced Melbourn and Poulton-le-Fylde were joint winners on 98 points so both these clubs will be automatically invited to next year's competition. What a great result for our Federation this was! Next year we have four automatic places plus two more to

be selected from the EAF Print Championships in March so I'm hoping to see more clubs enter in 2024. Next year, in order to better serve the spectators at the Print Championships, we will be requiring PDIs of the prints to be shown to the audience. The judges will still be judging the actual prints, of course. This should result in using the full resolution of the projector for the image without showing extraneous mountboard, not to mention any compromises occasioned by the extra processing involved in rephotographing the images and resizing them for projection.

In 2023 the EAF took on the running of the East Anglian AV Competition at the request of the Essex AV Group. The first EAF Audio-Visual Trophy took place at Foxton in October. Here Dick Williams reports on the event. Ed.

As the Chairman of The Essex AV Group, I have held the reins of the previously named East Anglian AV Competition for the past 30 years, and with the Group unable to continue, I find myself in a similar position heading the newly titled East Anglian Federation Audio-Visual Trophy. Eighteen months into the organisation of the event with a brilliant committee and a band of helpers we were prepared for the big day. Then, the bombshell, with two days before we were to set off to Foxton, one of our judges, Keith Brown, became unwell and was unable to travel from Sheffield.

Vic Hainsworth came to the rescue; he was prepared to judge alongside our remaining judge, Richard Brown, and saved the day. Vic has been involved with AV for over forty years and I think he relished the opportunity to judge the first EAF Audio-Visual Trophy albeit unplanned.

As EAF President, Vic opened the day before taking his place with Richard at the judges' table.

Now we were up and running after

the panic of the previous day. The event was a great success and we are now looking forward to next year.

**Amongst the positive feedback from attendees Ian Johnson LRPS gave his impressions of the day. Ed.**

In 2023 I entered and attended the EAF Audio-Visual Trophy for the first time. In total 41 sequences had been entered, making the undertaking an all-day event; heaven for any AV enthusiast. The subject matter of the sequences were as varied as from the end of the garden, to the end of the world – or to the other side of it at least. Dick Williams was a master as a 'master of ceremonies' Keith Leedham made all things technical run without a hitch.

One could not leave the event without being inspired – I certainly was. However, there were a couple of negatives for me in my mind in respect of the competition.

The first was the age of the competitors. At 61 years old I was one of the youngest, if not the youngest person

in attendance! We all, as Camera Club members, as a Federation and as ambassadors of photography, must spread the word of the wonders of Audio Visual to our younger members, friends and acquaintances. The second negative was the lack of feedback on the sequences – other than getting a medal if you had a really good one. Difficult I know given the time constraints, however, too long, too short, bad sound, bad voiceover would give the "novices" like me, some much needed help. Did the judges get it right? Of course not. The sequences on Chernobyl 'The Abandoned City', Myanmar 'A Troubled Country' and 'MoPop' were my personal top three. Am I going to enter next year? Bet your bottom dollar I will.

## EXHIBITION SECRETARY

**Important - we are making changes to the Annual Exhibition entry process in 2024.**

### New for 2024

Firstly you will be able to enter up to four mono and four colour prints this year as well as your PDIs. Send your PDI entry files – for the PDIs themselves as well as the PDI copy files for your prints – by On-Line transfer instead of the old physical DVD method. We recognise that the old system is now at the point where it is difficult to get hold of the discs and hardware needed to make an entry using physical media. Modern broadband transmission speeds and capacity are able to cope with the task efficiently and conveniently. We are suggesting that Clubs make their entry using WeTransfer, which is free for non-commercial use, but any similar file transfer system will work so long as it doesn't require sign-up or subscription fees or costs. Your entry will still go to the Collector for checking, along with your physical prints as before. We are also asking for Entry Listings to be made electronically and that these are transmitted with the image entry files at the same time. One thing we will not be able to change is the GDPR declaration for each Club member who enters. This will still be a requirement and the combined GDPR declaration and fee summary form method will be used for this. Your Club will be able to

complete this form as before, then scan it to pdf format and send it in with the entry. A physical copy will also be acceptable if sent in with your Print entry boxes.

The preferred method for payment from Clubs will be by On-Line Banking direct to the EAF account. Full details will be sent out to Club Secretaries shortly.

### Exhibition Venue

This year will be the last time we hold the Exhibition at Wingfield Barns. We have plans to change to a new location. Wingfield Barns has been a wonderful venue for our Annual Exhibition and is a beautiful setting, particularly for the print display in the galleries. Any new venue will face a challenge to match the setting at Wingfield but we are hoping that a change to a more accessible venue will help to attract more participation in the event and increased enjoyment of our photography across the Federation.

## PAGB GUIDANCE for using ARTIFICIAL INTELLIGENCE

Introduction This guidance amplifies the General Conditions for PAGB Events. It applies directly to all images submitted to PAGB events. This guidance may be adopted by others including Federations and Clubs or may be modified for their own use in any way at their discretion.

Principles How an individual creates an image for their own use, and what source material is coopted for image creation, is entirely at the individual's discretion. But, when an image is submitted alongside the images of others into a competition or exhibition, then each participant needs to be assured that the other participants are using only their own original work. The PAGB sets out to give that assurance within its General Conditions.

**Images must be entirely the work of the photographer. In composite images all component images must meet this requirement.**

There is a distinction between the image content, which is controlled by the General Conditions, and image processing and presentation which is at the photographer's discretion. Processing can utilise techniques such as selection, noise reduction, calculated textures, montage, HDR, focus stacking and many others. Presentation may include keylines, print paper types, print mounting and others. Photographers who enter PAGB

events with images which do not meet the General Conditions are liable to sanctions under the PAGB Breach of Rules Procedure. The Breach of Rules Procedure may also apply to other events such as those with PAGB Patronage.

Image Automation There are now many image processing methods available in camera, or in processing software or in plug-ins for such software, which have been refined or trained by their developers using the characteristics of many images. The list of methods is extremely long with examples such as face-detection focussing, raw conversion, monochrome conversion, noise reduction, focus stacking, HDR, panorama stitching and many more.

To the extent that these processes are applied only to the photographer's original image, or to all the photographer's original images in a composite, then they comply with the PAGB General Conditions.

Image Generation Banks of individual textures and skies have been available for some time and there are software systems which will overlay an imported texture or substitute a sky.

Increasingly there are image generator systems which draw on, or have been developed or trained on, content from large image banks to create new images, via a user prompt or specification.

Any importation, whether manual or automated, of all or part of a single

image or of a generated image which includes or has been developed from the work of others, means that the resulting image content is not entirely the work of the photographer. The resulting image then does not comply with the PAGB General Conditions and is not permitted where those conditions apply.

Compliance It is appreciated that the individual photographer may not be fully aware of exactly how individual processing functions act, whether in-camera or in post-processing. However, the PAGB would expect photographers to be aware of when a significant addition has been made to an image which was not part of an original work by the photographer.

### ONLY YOU CAN KNOW

**This article by the PAGB e-news Editor, Rod Wheelans, is reproduced with his kind permission. Ed.**

As e-news Editor, I have received numerous communications, verbally and by e-mail, and I have followed many discussions, sometimes confusing, on social media about how much effort a photographer should put into an image to make it their own.

Many have claimed that they know of instances involving Remote Shooting, Nature Hides, Studio Workshops and Organised Photographic Events where the photographer has had no input at all, except to press the shutter. Many have never been involved in such activities but assume that

there must have been lots of help, perhaps because they have not previously seen the same quality of work from that person.

There are also frequently expressed concerns about processing tools and techniques, exacerbated now by the perceived effect of Artificial Intelligence. How much of the final image is down to the work of others writing clever algorithms and how much did the photographer contribute?

The PAGB has no rules to define how much help you can have and, indeed, we accept entries which have been printed by someone else, even into the Masters of Print. We take the view that the entrant has ultimate responsibility for the image.

Amateur photography, as practiced through Camera Clubs, is a social activity and Members are encouraged to learn from each other and to help each other improve their Art and their Craft. Most Club Members have benefitted from assistance in their Club and many, many Members have been willing to help - from advising on camera settings in the field or in the studio, helping with composition and exposure, helping to process and print images to constructively criticising the final product and showing how it could be improved. Such activity is the very essence of most good Clubs!

Most organised events and photoshoot require the full participation of the photographer and, as a well-known organiser once said to

me, "I give you the ingredients, but you have to make the cake". If you weren't there, please don't be quick to judge.

It may well be true that some photographers have very little input to the images they have taken and may not do much to process them later. If you haven't made the INPUT, can you claim the OUTPUT? When it comes to post processing the PAGB already requires the entrant to have shot every element of an image and this, whilst more complicated, will not change with AI or other processing tools. In the end, whilst organisers may find it difficult to detect, you will know if you have gone too far.

**ONLY YOU CAN KNOW.** Do you believe in your heart that you have contributed enough to feel that you own this image? If you don't feel that way, and you are successful in competitions with it, then what have you won?

You may have won a medal but where is the satisfaction if most of the credit is due to someone else? Your name may be on the medal, but YOU know that it should be someone else being recognised. Be honest with yourself and you will gain much greater satisfaction from your photographic successes.

Sunday was a much shorter day as there were only 45 applications in PDI, split between 'C' and 'D'. The assessments were finished by lunchtime.

Formed in April 1964 as part of the Cine Club, the Society has moved from various halls in Ware including 25 years at Place House. When the lease ran out the Society moved to the Arts Centre in 2008. However, a new Arts Centre was being set up and the proposed rent was too high. As a result, the Society moved to Thundridge Village Hall which is on the outskirts of Ware and where the Exhibition is held every November. Over the years the Society, which is a member of the EAF, has been one of the leading Clubs in the country and members have regularly had acceptances in National and International Exhibitions. The Society has also been successful in the EAF Print Championships and the Inter-Club Print Championships. Several of its members have served on the EAF Executive Committee, supporting the Federation's work with two members being past Presidents.

Another new group, a 'Creative Vision Group', has just had its first meeting and was attended by over 25 members. We are encouraging our members to use this as a discussion group to further develop individuals' creative photography skills and awareness.

The SIG activity is all underpinned with weekly meetings of photographic talks and competitions.

In the past we have run a week-long Annual Exhibition of Prints and PDIs, in central Cambridge, with awards presented on the opening evening, by the Mayor of Cambridge and our sponsors.

Another major annual event that we host is Inter-Club Digital Competition for clubs in the EAF, typically held at

Whittlesford in January, which attracts around 30 - 35 clubs.
