REPORT FROM THE (VERY NEW) GENERAL SECRETARY – Sue Dobson

At the Federation Annual General Meeting in March I relinquished the post of Judges' Officer and took over as General Secretary. I follow in the footsteps of Stan Searle who retired after many years looking after the administration of the Federation in a highly efficient manner. I would like to take this opportunity of publicly thanking Stan for his help over the past months as I have settled into the post.

The first major task I have undertaken has been production of the 2011 - 2012 Club Directory, and secretaries will have recently received their copies. This booklet contains contact details of club secretaries along with information about club venues, meeting times etc. It has been drawn up using information passed to me in response to my request for updates. Something that has caught my attention is that a number of club secretaries do not list an email address. I have also noticed how much it costs to get material out to clubs due to rocketing postal charges - a second class mail shot to all clubs at current prices costs the Federation £43.20 in postage alone. It is not surprising then that I should be giving serious

consideration to contacting club secretaries wherever possible using email. However, this will only work if club secretaries report changes to their email addresses to me immediately.

Many clubs do not include a postcode for their meeting place. These days' judges and lecturers frequently use a "satnav" requiring a postcode to highlight a destination. Venue addresses often appear extraordinarily imprecise and inclusion of the postcode will be of use in situations when a visitor is looking for something as vague as "village hall" with no road name in a town never visited before!

And just a final comment: please be sure to pass on the PAGB Handbook to the club member who most needs it (programme secretary, perhaps) and in order to avoid confusion and embarrassment, please be sure that all old copies of this document, and the Club Directory, are destroyed. **SUE**

I am sorry that I was unable to accommodate everyone but we did try our best. I have never been in the situation of having such an immediate response to the publicity – we were totally sold out in just two weeks - if only it was always thus!

Moving on, by the time you have an opportunity to read this, your Club Secretary will hopefully have already received the publicity poster and mentioned the "Prints for All" Event taking place on Sunday 6th November at the Townley Memorial Hall, Fulbourn – a different venue just off the A14 near Cambridge where there is plenty of Car Parking and a Social Club attached that will offer refreshments at lunchtime!

Anne Cassidy FRPS FIPF AFIAP all the way from Northern Ireland will start the day with a talk entitled "Talking Pictures" - thus enabling Anne to fly back home late afternoon. Anne is a judge on the Licentiateship panel for the RPS distinctions and has just completed her studies for a Masters Degree in photography at the University of Ulster. She works mainly on documentary projects in both monochrome and colour and also creative art in colour.

After Lunch Clive Tanner FRPS will show us images under the title of "Divine Light". This will consist of his Fellowship panel in Silver Prints, but will also include colour and monochrome Digital Prints. Clive started taking photographs seriously when he joined Tonbridge Camera Club in the 1970's and says that chance caused him to try architectural photography but once tried he was hooked! He gained his Fellowship with large format monochrome prints in the Applied category and has since also been an assessor on the RPS "L", "A" and "F" Panels. Having retired from full time employment Clive and a couple of friends started archiving their local museum's small artefacts, putting some of his experience to good use. Although still dabbling with all sorts

of subject matter, ecclesiastical architecture and sculpture still remains his favourite genre of photography.

Finally Margaret Salisbury FRPS MFIAP FIPF APAGB will round off the day with her talk entitled "Dragonpix" and will include both monochrome and colour prints. Margaret tells us that she not only enjoys her photography, but also the opportunities it opens up e.g. relating to and meeting people from all walks of life and all over the world and never tires of seeing the world through the lens of a camera!. Her talk will include images taken when she had an opportunity to experience life in primitive villages in Ghana and met people who were happy to be photographed going about their everyday lives. In addition Margaret aims to show a wide range of subject matter to provide "something for everyone" including images from a visit to the Carnival in Venice and landscapes from the UK to the USA. All coupled with the wonderful "stories" that go with the pictures – told in a way that only Margaret can!

All being well we should be able to digitally project the work of each Speaker onto a 6' Screen, so that there will be an opportunity to see the details within the pictures.

However, the Prints themselves will still remain the main object of the Day and take centre stage. We will not therefore spend time ensuring the colours are 100% correct as the purpose is only to allow details to be viewed easily.

Publicity and Application forms for tickets will be sent to your Club Secretary in early September they can also be found on the EAF Website, with application forms to download as well. Don't miss the opportunity to see the work of three more superb photographers from outside our region, who normally live too far away to visit our region on a Club evening and please book early again - it saves me a lot of worry!. Taking the opportunity to see such work is one of the best ways to be inspired and learn more.

As usual the Gibberd Gallery,
Harlow was the venue for the 2011
Annual Exhibition. The Exhibition
was well attended during the two
weeks that it was open despite the
fact that the Gallery was closed on
Saturdays for economic reasons.

It was very pleasing that so many members attended the opening ceremony to see Cllr Sue Livings, Chairman of Harlow District Council and the President of the EAF, Malcolm Tinn, presenting the awards.

Although we received 1592 prints and 1040 digital images from members in the East Anglian region, sadly, due to limited gallery space, some very good work was unable to be selected.

The PAGB Inter-Federation Print Exhibition this year was organised by the Southern Photographic Federation with print selection taking place in June. In the monochrome print section we were placed 3rd out of 15 and in the colour print section we were 6th out of 15. The EAF are organising the PAGB Projected Images Competition and Exhibition and selection takes place in Harlow Photographic Society's club room in October; the results will be included in my next Bulletin report.

The 2012 Exhibition is now in its planning stages and the Gibberd Gallery in Harlow has been booked for the period Saturday 5 May (presentation of awards) to Friday 18 May (closed on Saturday 12 May). Prints and digital images

need to be with the collectors by Sunday 11 March 2012. Entry forms will be ready for collection at this year's EAF Championships meeting on Sunday 12 February 2012. However all the information will be available on the EAF Website from the beginning of next year.

The best prints and projected images from the Exhibition will go forward for selection for the PAGB's Inter-Federation Competition and Exhibition 2012. Please therefore ensure that your prints are on 40cm x 50cm mounts with a maximum thickness of 3mm. Prints not conforming to this standard cannot be accepted as they fall outside the PAGB's exacting requirements.

My thanks go to all the members of the Exhibition Sub-committee for their help, expertise and encouragement during the past year.

Suffolk Monochrome Group Exhibition to be held at the Mercury Theatre, Digby Gallery, Colchester Tuesday 25th October to Saturday 12th November

COMPETITION SECRETARY 3rd Projected Digital Image (PDI) and 6th Print Championships Latton Bush Centre, Harlow, Sunday, 13th February 2011.

My thanks go to the EAF Executive, their spouses and all other helpers for their organisation and team work on the day. It is only with their help that the day runs so smoothly.

The continuing trend in the rise in the number of clubs taking part meant we had 36 clubs (+1 on last year) taking part in the PDI and 27 clubs (+2 on last year) in the Print Championships. There could have been 39 clubs taking part in the PDI Championships but two clubs did not get their entry in before the deadline and one club did not get their images on CD to me by the deadline. Please note if I give a deadline, I keep to it.

This year's PDI Championship took much longer to judge than it had in previous years. There was one club extra taking part this year and on my past experience that should have meant just an additional five minutes or so, but it didn't. That made for a shorter lunch break too. That troubled several clubs and they voiced their opinions at the AGM in March. It troubled me too and at the Competition Sub Committee

that met in June we discussed this at length along with other competition-related items. Those findings have yet to go to the full Executive Meeting at the time of writing this article but as soon as they do I will post the decisions for the 2012 Championships on the EAF website. (www.eaf.org.uk, then go to Info>Championships.)

The judges for 2011 were Margaret Salisbury FRPS, APAGB, MFIAP, Clive Tanner FRPS and Peter Young CPAGB, APAGB.

The top two clubs from each championship are invited to represent the EAF in the relevant PAGB Club Championships. If any of those clubs were in the Final part of the previous year's PAGB championships (clubs are underlined below) they get an automatic invitation to enter this vear and another club is invited to enter. The clubs taking part in the 2011 PAGB PDI Club Championships will be: Beyond Group, Cambridge CC, Norfolk PG and Chelmsford CC. Those clubs taking part in the 2011 PAGB Print Club Championships will be: Cambridge CC, Beyond Group and Norfolk PG.

PAGB Club Projected Digital Image (PDI) Championships – 16th July 2011

University of Warwick's Art Centre.

Beyond Group, Cambridge CC, Norfolk Photography Group and Chelmsford CC were at Warwick representing the EAF with their PDI images. They were supported by members of several other EAF clubs — I counted six other clubs and there may have been more. It really is a good day out. Clubs from all over the UK come to compete. The judges were Rikki O'Neill FRPS, FIPF MPAGB, Richard Speirs DPAGB and Tony Wharton FRPS, AFIAP.

In a similar way to the EAF PDI Championship the PAGB Championship has two rounds/ sections. Every club takes part in the first section showing a total of 16 images. Then the top eight (or more clubs if there is a tie) take part in the Final showing a further twenty images. The remaining clubs take part in the Plate competition showing a further eight images. After 16 images Cambridge CC had 186 points, Beyond Group had 182 points, Norfolk PG had 176 points and Chelmsford CC had 166 points. The top score was 202. In the Plate competition both Norfolk PG and Chelmsford CC finished on 93 points in =9th position. The top score here was 100 so you can tell the marking was tight. In the Final competition, in which ten clubs took part, Beyond Group came =7th on 236 points and Cambridge CC came 9th on 233 points. The top score was 259 from Wigan 10.

Well done to Beyond Group, Cambridge CC, Norfolk Photography Group and Chelmsford CC - thank you for representing the EAF in these championships.



PAGB Executive Member Daphne Hanson CPAGB APAGB

Since my Spring report I attended the Annual General Meeting of the Photographic Alliance of Gt. Britain (PAGB) on Saturday 9th April 2011, together with the EAF President, Malcolm Tinn LRPS LBIPP, Mrs Sue Dobson CPAGB APAGB, Mrs Naomi Saul ARPS EFIAP DPAGB, Eric Saul ARPS EFIAP DPAGB and Andy Hanson MPAGB ARPS APAGB FIPF.

The Treasurer tabled the statement of accounts and balance sheet for the year ended 31st December 2010, showing total accumulated funds of £31,363. The PAGB annual subscription was not increased and will remain at £29.00 as from 1st January 2012. The Trustee Liability Insurance premium for the period 1st February 2011 to 31st January 2012 is £5.75 per club.

Don Langford retired as President of the PAGB and said how much he had

enjoyed his term of office over the last two years. Peter Cheetham APAGB was installed as the new President, and Leo Rich was elected Vice President.

A motion was put to the meeting as tabled by the PAGB Executive, that some Federations are finding it difficult to qualify for the Awards for Photographic Merit, and it was proposed that the only qualifying requirement is that an entrant is a paid up and "active member of an affiliated club". The proposal was discussed at some length, was put to the vote and the motion was carried. Each Federation has the prerogative to decide upon their own interpretation of the new criteria and the FAF Executive will discuss this at their next meeting in September. It was pointed out however that Federations will still be required to approve the application and the time specification will still apply i.e. 2 years for CPAGB, 3 years for DPAGB and 5 years for MPAGB.

FIAP:

77 Distinctions were awarded in March 2011. In the EAF, EFIAP Bronze was awarded to Gordon Bramham, with AFIAP to Ann Burley, Nick Burley and Jim Price. In a second submission of FIAP applications, EFIAP was awarded to Richard Cherry, and AFIAP was awarded to Kevin Elsby, Jon Martin and Fred Price. Congratulations to everyone.

Inter-Federation Print Competitions/ Exhibition:

The Inter-Federation Print Competition/Exhibition was judged on the 12th June 2011, hosted by the Southern Photographic Federation. The Monochrome Print Competition and the Colour Print Competition was won by the Midland Counties Photographic Federation. The Stirling Trophy and the Alexander Keighley Trophy were presented to the President of the Midland Counties, Mrs Judith Parry, at the Inter-Club PDI Championship at Warwick in July. The Print Exhibition comprising 150 framed photographs is now touring the country. Full details of venues and opening times are found on the PAGB website: www.pagb-photographyuk.co.uk.

Inter-Federation Projected Image Competition/Exhibition:

This competition will be judged on 16th October 2011 hosted by the EAF. The deadline date for Federation entries is 1st October 2011. An Exhibition CD will be produced and sent to the Federations in November.

The PAGB is proposing to double the entry for the Inter-Federation PDI

Competition, which at present is 50% of the total number of Federation clubs. Further discussion will take place at the PAGB Executive meeting in October.

The Print and Projected Image
Competition Rules have been amended
in order to have a common policy
on photographic ownership, which
will cover all PAGB competitions and
the PAGB Awards for Photographic
Merit. The Rules state "Images
entered must be entirely the work of
the photographer. Composite images
are permitted provided all component
images meet this requirement".

The use of images, or parts of images in Awards for Audio Visual were discussed in great detail and it was decided to continue with the current criteria at present, in that all sequences submitted for the Awards must contain sufficient evidence of "good photography". The Standards Committee have been asked to prepare a discussion paper on Audio Visual Awards for the Executive Meeting in October.

Inter-club PDI Championship: This event took place at Warwick University on Saturday 16th July 2011, sponsored by Darwin Clayton (UK) Ltd, Fotospeed and Harman Technology Ltd. Wigan 10 came out on top once again. Pencil next year's date in your diary – Saturday 14th July 2012.

Inter-club Print Championship: This year's event will take place at Deeside College, Connah's Quay, Flintshire on

Saturday 22nd October 2011 at 10.00 am. Tickets are £10.00 each. Details are available on the PAGB website: http://www.pagb-photography-uk.co. uk.

PAGB Judges: New judges added to the list: Allan Gawthorpe EFIAP/s DPAGB, Peter Paterson FRPS EFIAP MPAGB, Al Buntin ARPS, Robert Fulton EFIAP MPAGB ARPS and Karen Berry ARPS all from the Scottish Photographic Federation.

The PAGB Great British Cup: The closing date for the 2012 competition is 9th January 2012. The three sections are: 'Open', 'Nature' and 'Small Clubs'. Judging will take place on 11th/12th February 2012. CD's for the 2011 competition will be distributed in August.

Patronage: David Gibbins has taken over Patronage applications. Details will be available in the new PAGB Handbook due to be published in August.

Recorded Lecture Service: All slide lectures have now been withdrawn and a copy sent to the PAGB Archive. Groups 1 and 2 of the RLS have been merged and will be administered by Stephanie Cook – Stephanie. Cook@btinternet.com. The GB Cup CD's will be included in the RLS list. A PAGB Awards for Photographic Merit CD for CPAGB and DPAGB Awards is being prepared and should be available

in October. It is hoped to produce a separate CD for the MPAGB Award next year.

PAGB Expenses for Lecturers/Judges

The mileage rate for travelling expenses will be increased from 22p per mile to a maximum of 30p per mile, plus the cost of fuel, effective from the date of issue of the new Handbook.

Insurance

Gordon Jenkins the Insurance Officer reported that some local authorities are insisting that clubs using their premises carry Public Liability Insurance to the sum of £5 million. Darwin Clayton therefore strongly recommends that the minimum cover for PLI should be £2 million.

Having a good evening.

When you sit there mesmerized, impressed or dare I say it "bored to death" do you ever wonder where the speaker or judge came from? I suspect you do. Speakers and judges are invited by the Club's Programme or Judges Secretary who will have scanned the Lecturers and Judges Handbook provided by the East Anglian Federation of Photographic Societies (EAF), which has 117 clubs and is the largest Federation in the country These booklets are provided annually to all EAF clubs setting out the latest information about Judges and Lecturers as to topics, how far they will travel and days they would not be available as sometimes these clash with their own club night.

In addition to the booklets containing EAF judges and lecturers, clubs receive from the FAF a handbook issued biannually by the PAGB on behalf of the Federations which contains all the lecturers and judges available throughout the United Kingdom. This is invaluable since it gives us access to all the leading lecturers and judges in the country who, if invited, might be prepared to visit a club, at nationally agreed rates. Of course, for many clubs the expenditure involved would be too great for many of them so the EAF holds a print and digital event in March and November respectively to which the leading photography exponents are invited. These are very popular and

often over subscribed. They have also been very profitable for the EAF with the surpluses helping to keep the club subscriptions to a minimum level.

Judges and lecturers give their time voluntarily but are paid travelling expenses based on national rates that cover all Federations. People who lecture professionally are in a separate section of the handbook and their charges are shown. A worrying trend for Programme Secretaries these days is the increasing use of add-ons such as "£20 for use of equipment" by people who previously only required travelling expenses and a cup of tea and a biscuit!

Anyone can be a judge and/or lecturer and it is not necessary to go on a course to be one. It is however recommended by the EAF that people wishing to judge should do so as they would pick up some tips on public speaking and what is expected of them when they visit a club. The EAF has a system of grading judges into A, B or C. categories where A is considered the highest category. I'm not sure how much value can be placed on this system as some Federations seem to be able to function very well without it. For lecturers, there are no such courses and people are left to their own devices, so, whilst a lecture in the handbook might appear attractive it is always sensible for the Programme Secretary to make a few enquiries from reliable sources before making a booking.

Of course clubs have a responsibility in how they treat their guest judges and lecturers. They should be welcomed and met on arrival, introduced and thanked properly and the guidance give in the handbook about how they should be treated, particularly in regard to expenses, should be followed. They should not be expected to move chairs, tables and set up equipment as has been known to happen in some clubs. Also, please be sociable and talk to them at suitable times during the evening. Don't treat them as though

they have the plague and ignore them. However they should not be delayed when trying to get away at the close of the meeting. It should be borne in mind that a lecturer or judge might have at least a two hour journey home to make in possibly difficult road and wintry conditions. Make sure that your club is one which the judge or lecturer would be happy to make a return visit and you'll be sure to have had a good evening.



VELCRO MOUNTING CLIPS

When pins into soft display board will not take the weight of large mounts, then to avoid attaching Velcro to them directly, Jim Newman of Hoddesdon C. C. offers a very simple and inexpensive idea.

Cut white plastic double-width electrical conduit into short pieces. Cut /saw along the narrow edge of each to spring open for the mount, and put Velcro on the broad face. See pic.

He adds: before cutting the length of conduit from the DIY Store, wash it with a touch of detergent to ensure the Velcro pads stick well.

When no cheque appeared, upon enquiry I was told "Oh, there was another picture. We didn't use yours".

After a sharp reminder of our agreement a cheque appeared by return with a courteous letter, but pointing out that normally theirs was the trade policy of only paying upon publication.

Be aware that to sell a picture to 'put in a frame', and to put in a publication are two different things. Gordon Anderson.



As a dedicated member of S.P.S. John really enjoyed promoting our Society and gave talks locally until very recently. He was awarded his APAGB in 1990 and was an EAF Judge for many years.
